- **Promote in-person interactions with friends-** This is essential for adolescents susceptible to social anxiety disorder.
- **Discuss social media-** Discuss your own engagement with social media. Ask your adolescent about their social media usage and its impact on them. Advise your adolescent that images on social media are often exaggerated.
